## PREFACE TO THE FOURTH EDITION.

---

IN the sixteen years that have elapsed since the last edition of the Book several important changes have been made in the Law. The Ground Game Act, which was passed in the interests of good husbandry to settle disputes between landlord and tenant, has only made the existing confusion still worse, while the legislation as to Wild Birds, however well meant and however necessary, has had the practical result of extending the Law for the protection of the birds of the country in a way that twenty-five years ago would have been considered impossible. It is no longer a certain class of birds that are protected, but all birds, and probably at no time has the Law as to Wild Birds been so stringent as now. The result is that the Game Laws have become of less importance than the present Law as to Wild Birds. Every effort has been made to make this Book a complete statement of the Law up to date, but with the constant changes made by County Councils it is no easy task.
